4-H Donation: Upon a motion by Annexstad and seconded by Hulke, it was approved to sponsor the 4-H demonstration awards by offering a \$25.00 award to each individual or team whose

demonstration is related to wildlife, forestry, conservation or soil and water conservation. Ayes Braun, Hulke, Annexstad. Carried.

Area VI Meeting, July 16th, Turner Hall in New Ulm: Attendance for Area VI Meeting for Staff and Supervisors was approved at the June Board Meeting. There was discussion as to who will attend the July Area VI Meeting. No motion needed.

Garage Update: Ostermann reported that the garage should be completed in a couple of weeks. We are on budget. This was informational only; no motion needed.

2019 BWSR Academy: A motion was made by Annexstad and seconded by Hulke for SWCD Staff to attend the 2019 BWSR Academy on October 29 – 31 at Breezy Point. Ayes Hulke, Braun, Annexstad. Carried.

Connecting Nicollet County Update: This was a follow up to last month's discussion regarding the possibility of having the Connecting Nicollet County group stop by the SWCD office when they are touring Nicollet. Beetch contacted the CNC Program Coordinator, who said she would pass our information on to the day-chair. The group is scheduled to be in Nicollet in September. This was informational only and no motion needed.

Cost Share:

The District received a request from Danny Boisen 16(18) for final payment on his Buffer Cost-Share Contract for the seeding of 4.13 acres of buffers on his property. Costs of the project is \$1,239.00 with TA cost of \$309.75. Upon a motion by Annexstad and seconded by Hulke, it was moved to approve final payment for \$1,239.00 or 100% of the total cost of Danny Boisen Buffer Cost-Share 16(18). Ayes Braun, Hulke, Annexstad. Carried.

A request was presented to the Board for final payment on Buffer Cost-Share Contract 21(18) with Jeremy Flugge for buffer installation on his property. Cost of the project is \$600.00 and technical assistance of \$150.00. Upon a motion by Annexstad and seconded by Hulke, it was moved to approve final payment for \$600.00 or 100% of the total cost of the 2 acres that were seeded for Buffer Cost-Share Contract 21(18) with Jeremy Flugge. Ayes Braun, Hulke, Annexstad. Carried.

NRCS Report: April Sullivan reported that she had 50 EQIP applications. There will be a Water Quality Tour taking place in September with a targeted audience including the metro legislators. Jake Stich from the NRCS Glencoe Team also attended the meeting.

Supervisor & Staff Report: Hulke reported on a TSA Meeting that he attended on June 25. Staff submitted reports on various projects and trainings.
