Total estimated cost of \$602.00; cost share portion not to exceed \$300.00 or 75% of eligible cost, whichever is less (technical assistance \$75.00). Upon a motion by Gieseke and seconded by Kral, to allocate: \$300.00 from the State Cost Share Grant FY2013 with TA of \$75.00 for C-S contract Kevin Kiecker 6(13). Ayes Brown, Gieseke, Hulke, Olson, Kral. Carried

The District received a request for cost share assistance from Harlan Olson 7(13) for assistance to install a windbreak. Total estimated cost of \$1,500.00; cost share portion not to exceed \$900.00 or 75% of eligible cost, whichever is less (technical assistance \$225.00). Upon a motion by Hulke and seconded by Kral, to allocate: \$900.00 from the State Cost Share Grant FY2013 with TA of \$250.00 for C-S contract Harlan Olson 7(13). The District received a request for cost share assistance from Justin Hawker 8(13) for assistance to install a windbreak. Total estimated cost of \$2,100.00; cost share portion not to exceed \$1,505.00 or 75% of eligible cost, whichever is less (technical assistance \$376.25). Upon a motion by Kral and seconded by Olson, to allocate: \$1,505.00 from the State Cost Share Grant FY2013 with TA of \$376.25 for C-S contract Donald Stark 8(13). The District received a request for cost share assistance from Wakefield Pork 9(13) for assistance to install a windbreak. Total estimated cost of \$3,528.50; cost share portion not to exceed \$2,070.00 or 75% of eligible cost, whichever is less (technical assistance \$517.50). Upon a motion by Gieseke and seconded by Hulke, to allocate: \$2,070.00 from the State Cost Share
