Cost—Share contract 11(13) & 1(14) for Bruce Burnett Well Sealing is completed. Total cost of the project is \$2,411.88. Upon a motion by Olson and seconded by Gieseke, it was moved to approve a payment of \$79.14 FY13 & \$670.86 FY14 for C-S contract 11(13) & 1(14) and Technical Assistance of \$19.79 FY13 & \$167.72 FY14, for Bruce Burnett. Cost-Share contract 1(13) for Grant Metz Well Sealing project is complete. Total cost of the project is \$1,785.00.
